I MOVE that this Assembly recommends that the *Elections and Plebiscites Act* be amended to provide that, during the election period, candidates declare compliance with a code of conduct including the duties to abide by the laws of the Northwest Territories and Canada; to conduct his/herself with honesty, integrity, and respect for others; and to refrain from actions that would, upon election, create or be perceived to create a conflict of interest as set out in Section 74 of the *Legislative Assembly and Executive Council Act*.

I MOVE that this Assembly recommend that the *Elections and Plebiscites Act* be amended to include a five-year limit on eligibility for candidacy for anyone convicted of an offence of violence or threats of violence under the *Criminal Code of Canada* and who has not received a pardon or record suspension; and where the offence was committed against a person over whom the accused was determined by the presiding judge to be in a position of trust, authority, or intimacy; and, if applicable, that the limitation not apply to offences committed before the coming-into-force date of this amendment; and that a consequential

amendment of Section 6 of the *Legislative Assembly and Executive Council Act* ensure consistency of qualification of sitting Members and candidates.

- c) I will faithfully, to the best of my ability, perform the duties and responsibilities of my office, and will not allow any direct or indirect monetary or other personal or private interest to influence my conduct or affect my duties in public matters;
- d) I hereby affirm, subscribe to, and agree to follow the Members' Conduct Guidelines, or Members' Code of Conduct, if applicable, adopted by the Legislative Assembly, in the case where the oath is sworn, so help me God."
