 NWT Candidates**

The NWT Family Violence Action Plan: Phase II (2007 - 2010) is sun-setting in March 2012. The Coalition Against Family Violence has put forth 19 recommendations on priority areas which require continued funding. Do you support these recommendations?

A severe shortage of quality and affordable childcare exists across the NWT. Due to the lack of childcare options, women are unable to work, take training or attend wellness programs. If elected, would you commit to helping all communities in the NWT build affordable, quality licensed childcare facilities?

According to Status of Women Canada, "Gender-Based Analysis is a highly adaptable tool that you can use to work towards positive social and economic change. Every action, policy, program, project, and socio-economic trend affects men and women differently." If elected, what actions would you take to ensure the implementation of Gender-Based Analysis in new and existing GNWT policies, programs, and legislation?
